Proof of completed supply in the form of certificate of completed supply with reference to order no. need to be submitted.
- (c) Bidder should furnish certified copy of latest Audited Annual report along with their PAN and GST Nos.
- (d) The Frozen Semen producers or their authorized channelshould have an annual average financial turnover, during last 03 years ending 31<sup>st</sup> March of the previous financial year, at least Rs.**20.00 lacs.**
- (e) **Work Experience:** The experience of the prospective bidder should be as below:
  - i) Three similar completed works costing not less than the

Reaction).

- c) Concentration: Not less than 2.1 Million Progressively motile sperm per dose.
- d) Packed in 0.25 ml French Mini straws with low absorbance
- e) Post thaw motility: Progressive motility of minimum 1.05 Million sperm per dose at 0 hr incubation.
- f) Intact Acrosomes: Greater than or equal to 50% of the total motile cells.
- g) The bacterial load shall not be more than 5000 CFU per ml
- h) Should Have a CMU certificate A grade Semen station in Last Six months
- i) Field concentration rates (relative conception rates) across herds should not be less than 90 % of the Conventional semen under similar conditions.
- j) Processor should have at least 2 years of experience in indigenous breed bull semen sexing or produced more than 1,00,000 SFSD of indigenous breed bull

- 2. - 3. The tender shall be opened by the tender committee duly constituted by the competentauthorityaspertheschedulegivenabove. #### 11. <u>Delivery</u>:-
