In exercise of the powers conferred by sub-section (1) and (2) of Section (3) Prevention of Cruelty to Animals (Establishment and Regulation of the Societies for Prevention of Cruelty to Animals) Rules, 2001, of PCA Act, 1960, the Government of Goa is pleased to notify the District Society for Prevention of Cruelty to Animals, and its respective Management Committee, for North Goa and South Goa, as under.

**MEMORANDUM OF THE SOCIETY**

These Societies for Prevention of Cruelty to Animals (SPCAs) are established in terms of the Prevention of Cruelty to Animals Act (Establishment and Regulation of Societies for Prevention of Cruelty to Animal) Rules, 2001, for the welfare and protection of animals and to implement the provision of the Prevention of Cruelty to Animals Act, 1960 and the rules made thereunder.

1. Name of the Society:

North Goa	South Goa
The name of the Society shall be 'Society for Prevention of Cruelty to Animals, North Goa (in short) SPCA North Goa	The name of the Society shall be 'Society for Prevention of Cruelty to Animals, South Goa, (in short) SPCA South Goa.

2. Address of the Society:

North Goa	South Goa
The address of the society shall be, The Collector North, Office of the Collector, Panaji-Goa	The address of the society shall be, The Collector South, 4th Floor, Mathany Saldhana Adm. Complex, Collectorate South, Margao-Goa.

3. Jurisdiction:

North Goa	South Goa
Society shall cover the entire area of North Goa District	Society shall cover the entire area of South Goa District.

4. Objectives of the Societies shall be as under:

- a) Promotion of animal welfare generally for the purpose of preventing of cruelty and for protecting animals from being subjected to unnecessary pain or suffering, in particular when they are being transported or when they are used as performing animals or when they are kept in captivity or confinement.
- b) Establishment or encouraging the establishment of animal's shelters, water trough, pinjrapoles and the like for providing shelters and amenities to animals incapacitated for work etc. by reason of old age, sickness or injury.
- c) Rendering of veterinary assistance to sick and injured animal with the help of infirmaries and animal shelters.
- d) Imparting education in relation to the humane treatment of animals, build empathy towards animal, encouraging the formation of public opinion against the infliction of pain and suffering to animals, and for the promotion of animal welfare by means of lectures, books, posters, film shows, exhibitions and the like.
- e) Co-ordinating its work with the State and District Departments concerned with animals welfare and with the Animal Welfare Board of India (AWBI), State Animal Welfare Board, and with the registered Animal Welfare Organizations (AWOs) of the District.
- f) Animal Birth Control (ABC) for dogs, cats and any other animals as may be required.
- g) Employing of paid staff to watch, warn or prosecute, as required, all persons guilty of cruelty to animals.
- h) To take all measures and steps as may be required for the above objectives.

5. Constitution of Management Committee:

- a) The Management Committee shall consist of the following members as prescribed under Rule 3(2) of Prevention of Cruelty to Animals (Establishment and Regulation of Societies for Prevention of Cruelty to Animals) Rules, 2001 notified on 26th March, 2001.

6. Duties and the powers of the Society:	
a) To aid the Government, the Board and local authority in enforcing the provisions of the Act and to make such bye-laws and guidelines as it may deem necessary for the efficient discharge of its duties.	
b) The Society or any person authorized by it in this behalf, if it or he has reasonable grounds for believing that any person has committed an offence under the Act, it or such authorized person may require such person to produce forthwith any animal in his possession, control custody, or ownership, or any license, permit or any other document granted to such person or required to be kept by him under the provisions of the Act and may stop any vehicle or enter into any premises in order to conduct a search or inquiry and may seize an animal in respect of which it or such authorized person has reason to believe that an offence under the Act is being committed and deal with it in accordance with law.	
c) In addition to the powers conferred by these rules, the State Government may, in consultation with the Board, confer such other powers upon the Society for exercising the powers and discharging the functions assigned to it under these rules.	
7. Setting up of infirmaries and animal shelters:	
1. Every State Government shall provide adequate land and other facilities to the Society for the purpose of constructing infirmaries and animal shelters.	
2. Every infirmary and animal shelter shall have:-	
i) A full time veterinary doctor and other staff for the effective running and maintenance of such infirmary or animal shelter; and	
ii) An administrator who shall be appointed by the Society.	
1. Every Society shall, through its administrator or otherwise, supervise the overall functioning of the infirmaries and animal shelters under its control and jurisdiction.	
2. All cattle pounds and pinjrapoles owned and run by a local authority shall be managed by such authority jointly with the Society or Animal Welfare Organization.	

## 8. Regulation of SPCA's:

1. Every Society shall submit its annual report to the Board incorporating therein the activities undertaken by it for the welfare of animals and the steps or measures taken by it to implement various provisions of the Act and the rules made thereunder along with annual accounts duly audited by a chartered accountant or any other body authorized by law within a period of one month from the date or its accounts having been finalized by its managing committee.
2. The Board shall examine such annual report and the annual accounts submitted by the Society and may give any directions to it for improvement of its functioning including the supersession of the managing committee of the Society with a view to give effect to the provisions of the Act and the rules made thereunder.

Provided that the Board shall give opportunity of personal hearing to the office bearers of the society or any representative authorized by it before giving direction of its supersession and holding of fresh elections for electing a new managing committee as per bye-laws of the society.

3. The Board shall give any direction to any Society in the interest of smooth and efficient functioning of the Society including the procedure for holding the election of the managing committee of the Society, utilization of financial resources and management of assets of the Society with a view to give effect to the provisions of the Act and the rules made thereunder.

Read: 1. Notification No. 41/4/2008/TS/RCS/1522 dated 6th August, 2020.

1. Para 6 of revised OTS annexed to the notification dated 06-08-2020, read at Sr. No. 1 above shall be substituted and read as under "The overdue outstanding amount classified as NPA as on 31-03-2015 and have subsequently become doubtful or loss shall be recovered fully from loanee

member. The Board of Directors at their discretion shall charge simple rate of interest ranging from 5 to 10% depending on merit of each case to settle the loan cases application under OTS."

2. The expression "doubtful I" appearing in the OTS scheme shall be substituted with expression "Non-Performing Assets (NPA)."

3. In sub-clause (J) of point 6 titled "Compromise Formula" the expression "In case any loan is overdue (i.e. date of default) for more than seven years preceding cut-off date i.e. on 31st March, 2020 and is not secured by tangible security, such loan could be compromised under O.T.S., provided that the total amount recovered shall be at least double the principal loan availed. The loans upto Rupees Ten lakhs secured by tangible security could be compromised under OTS on the same line under this clause." shall be replaced and read as "In case any loan is overdue (i.e. date of default) for more than seven years preceding cut-off date i.e. on 31st March, 2020 and is not secured by

tangible security, such loan could be compromised under O.T.S., provided that the total amount recovered shall be at least double the principal loan availed. The loan accounts upto Rs. 20.00 lakhs outstanding with or without collateral of movable assets such as vehicles, machinery etc., could be compromised under OTS on the same line under this clause" figure appearing as Rs. 10.00 lakhs shall be read as Rs. 20.00 lakhs.

4. In the second para of "COVID EXIT" the expression "post 2015" i.e. cut off date of OTS upto 31-03-2020" shall be replaced by expression "upto 31-03-2020".

Rest contents of the Notification shall remain same.
