**Mukhyamantri Sudharit Kamdhenu
Scheme**

Introduction.— Mukhyamantri Sudharit Kamdhenu Scheme shall come into force from the date of Notification on Government of Goa Official Gazette and shall replace/supersede

the existing Kamdhenu Scheme (Sudharit) Amended 2021 accordingly.

This Mukhyamantri Sudharit Kamdhenu Scheme is strictly based upon the applicant fulfilling the following conditions:—

- The applicant has to be bonafide resident of Goa for at least 15 years.
- Shall possess a pucca cattle shed with cement flooring for housing the animals proposed to be reared.
- Undertake to strictly stall feed the animals and not allow open grazing except

in open paddock surrounding the cattle shed.

d. New applicant compulsorily has to undergo dairy training as decided by the Department of AH & VS at the designated training centre. Fresh applicants who are old traditional dairy farmers and are currently engaged in dairy activities themselves having crossbred animals/ improved Buffaloes/Indigenous cattle, but had not availed the Kamdhenu Scheme could be exempted from undergoing the dairy training and will be considered only on recommendation from the area officer.

The main reason for the success of the dairy programme in India is the involvement of milk producers in setting up their own organizations for milk production enhancement, milk procurement, processing and marketing. Dairying, as a subsidiary source of income, is a real relief to most of these weaker groups in society.

Animal Husbandry plays a vital role in providing household nutritional security, increased income, and employment especially of women and in rural transformation. Livestock provide economic security and social status to the family. Concentration of livestock in general and small ruminants in particular, is in marginal, small and semi-medium holding, which mostly represent poorer sections of the society. Thus progress in livestock sector is directly related to a more balanced development of rural economy and upliftment of the poor sections of the society.

Dairying with high yielding crossbred cattle, improved she buffaloes and indigenous breeds namely Sahiwal, Gir, Red Sindhi, Rathi and Tharparkar has become a remunerative business. Studies have shown that dairy enterprise as against crop in rural areas was on the top with regard to profit in marginal, small and medium holding. Dairying and crop production together for small farmers having irrigated land was more profitable than crop farming alone. Animal Husbandry components provide easy cash; therefore, small farmers prefer it to crop production.

To begin with and in order to accelerate at fast pace the daily milk production in the State the scheme is intended to be implemented with full zeal throughout the State.

Objectives of the Scheme.— The main objectives of the scheme are:

- ❖ To help the farmers to get financial assistance for the purchase of cross bred cows, improved she buffaloes and cows of indigenous breeds namely Sahiwal, Gir, Red Sindhi, Rathi and Tharparkar for his Dairy Unit.
- ❖ To promote self employment in the Dairy Sector.
- ❖ To boost the milk production in the State and to make State self sufficient.
- ❖ To strengthen the Dairy Co-operative movement in the State.
- ❖ To ensure sustainability and provide improved income and livelihood.
- ❖ To also encourage the schedule tribe and schedule caste communities.
- ❖ To create employment in the State.

Eligibility.—

- ◀ Farmer or his family who had availed the benefit of purchase of animals under the earlier Kamdhenu Scheme but has not exceeded purchase of more than 10 milch animals are eligible to avail the benefit of the scheme for remaining milch animals.
- ◀ Any person residing in Goa for 15 years or more.
- ◀ Knowledge or experience in Cattle or Buffaloes farming or trained by the Department.
- ◀ Land for green fodder cultivation desirable.
- ◀ Applicant should have a cattle shed to undertake the scheme.
- ◀ The farmer should have the cattle shed constructed on their own land and land/ cattle shed on lease/rent are not permitted.

- ◀ Only one cowshed is permitted under one survey number having area of less than 400 sq. meters.
- ◀ Multiple applicants are permitted to avail the scheme in the same survey number provided the share of undivided land/area is more than 400 sq. meters and NOC of co-applicants is obtained. The distance between the two cattle sheds should not be less than 5 meters on all sides. Each cow shed should have individual drainage system and roofing.
- ◀ Applications which were sanctioned earlier or lapsed orders after 2nd August, 2022 which could not result in purchase of milch animals during LSD outbreak have to submit a request letter for revalidation and can purchase after revalidation of their earlier order within 6 months of the issue of the order of revalidation.
- ◀ The applicant desiring revalidation of lapsed order has to apply within one month after the publication of the Gazette.
- ◀ The loose housing system in dairy is considered with cattle shed and open area (Paddock) between 80-200 sq. ft. per animal.
- ◀ The farmer/applicant whose spouse are Government employee must submit a declaration on their behalf to this Department stating the Department of the spouse, designation, place of posting and mobile number.
- Letter from financing institution having Electronic Clearance System (ECS) willing to finance the beneficiary.
- Passport size photograph of the applicant.
- Self Declaration where the applicant's spouse is a Government employee.

Detail Guidelines of the Scheme:

1) The scheme intends to provide self-employment to the youth by assisting the youth or any person desirous in establishing a Dairy Farm. Under the scheme the farmer can buy cross bred cows/improved she buffaloes/indigenous breed cows namely Sahiwal, Gir, Red Sindhi, Rathi and Tharparkar in one or more phases.

2) The eligible applicant should purchase the sanctioned animals within one year of sanction of the approval order. No revalidation is permitted.

3) Unit cost of the cross bred cow/ improved she buffalo/indigenous breed cow namely Sahiwal, Gir, Red Sindhi, Rathi and Tharparkar shall be limited to Rs. 70,000/- per animal expected to yield 2700 liters of milk per lactation for the purpose of release of subsidy.

4) Subsidy on the cost of the animal shall be as follows:

The eligible subsidy shall be credited to the Bank account of the beneficiary through ECS system of the concerned financing institution.

OR

One time relaxation, to those who have been issued orders previously under the

Documents to be produced:—

- Residence Certificate from Mamlatdar/ Sarpanch of minimum 15 years.
- Consent for seeding & Authentication of Aadhar/UID number.
- Affidavit in prescribed format regarding ownership of cattle shed.
- Caste Certificate of SC/ST/Dhangar.

Infrastructure Component of Kamdhenu Scheme (Sudharit) Amended 2021 will be allowed to purchase a maximum of 20 milch Animals. Similarly applicants who were issued orders to purchase milch animals under the Kamdhenu Scheme (Sudharit) Amended 2021 but could not purchase the animals because of the ban imposed due to LSD outbreak are permitted to purchase maximum of 20 milch animals (after revalidation of the order). In such cases the subsidy for the milch animals purchased will be as below:

5) Incentives towards transportation of the animals at the rate of Rs. 2,000/- (Rupees Two thousand only) per animal or actual cost of transportation, whichever is less shall be reimbursed to the beneficiary's Bank account through ECS along with subsidy amount.

6) Under the scheme, a beneficiary can purchase either crossbred cows/improved she buffaloes/indigenous breed cows namely Sahiwal, Gir, Red Sindhi, Rath and Tharparkar.

7) The farmer has to produce a letter from the financing institution having ECS system, willing to finance him for purchase of milch animals or for Infrastructure Component of the scheme.

8) All milch animals under the scheme have to be purchased from the Registered Supplier appointed by the Government.

a) Fulfilling all the conditions laid as required under Mukhyamantri Sudharit Kamdhenu Scheme viz. a well constructed cattle shed with pucca flooring and roofing, manger and dung channel or cattle shed fulfilling above criteria along with open area (Paddock) and following appropriate feeding and management practices.

b) Each farmer is permitted to purchase crossbred cows, improved she buffaloes/

/indigenous breed cows namely Sahiwal, Gir, Red Sindhi, Rath and Tharparkar from outside the State. Farmers who have availed any Government dairy scheme earlier as well as traditional dairy farmers having crossbred animals currently engaged in dairy business as well as fresh entrants who have undergone dairy training are permitted to purchase on recommendation of the local Area Officer. Purchases of milch animals are permitted in two phases only with a maximum of 5 animals in each phase.

c) Obtain prior written permission well in advance from the Department before undertaking purchases through registered dealer.

d) Be a member of the Local Dairy Society/Bachat Gat/Self help groups. The dairy farmers who are interested in branding their dairy products without membership of local milk unions may be permitted.

9) Upon purchase of milch animals supplier should intimate Director and local Area Officer within 24 hours of completion of purchase.

10) It shall be the sole responsibility of the supplier to insure the animals for Transit Insurance which is mandatory to take care of any uneventful incidence during transportation. Further the animals are to be compulsorily insured by the financial institution and beneficiary within 07 days of their arrival in the farm.

11) On purchase of animals the Officer has to submit the health certificate, purchase statement, purchase receipt, transport receipt to the financial institution for insuring the animals (within a week after purchase) and other required formalities, duly certified by the Assistant Director/Area Veterinary Officer along with the farmer and Bank Officials.

12) The purchase statement and documents as stated at '11' above shall be submitted to Head Office by the financial institution within 2 weeks of effecting purchase so as to enable release of subsidy.

13) Identification of animals purchased through this scheme must be done through RFID ear tags. Animals on reaching in the cattle shed of the farmer microchipping of the animals to be undertaken. The existing cross bred cows/improved she buffaloes/indigenous breed cows namely Sahiwal, Gir, Red Sindhi, Rathi and Tharparkar shall be identified by microchip and INAPH ear tags.

14) Release of subsidy will depend on the receipt of the documents mentioned at clause (11) above, which should be submitted duly completed, by the financing institution through the Area Officer along with the xerox copy of the passbook, within a month by the farmer.

15) Animals purchased under the scheme should be insured for minimum period of a 3½ years under the Comprehensive Insurance Policy with such Insurance Agency/company as the Department may from time to time notify (approved by the Government). It shall be the sole responsibility of the beneficiary to insure the animals immediately on purchase. The Government shall not be responsible in the event of the death of the animal or otherwise. The respective financing institution shall be responsible for the tie up arrangement of insurance cover between the beneficiary and the Insurance Company. The premium towards Insurance should be initially borne by the beneficiaries/financing institution, the Department shall reimburse the premium amount to a maximum of Rs. 16,625/- (Rupees Sixteen thousand six hundred twenty five only) per animal directly to the financing institution, together with the subsidy amount on receipt of all the required documents in order.

16) The animals purchased under the scheme cannot be disposed off for a minimum period of 3½ years. In case of default, Government shall recover subsidy amount paid to beneficiary of the milch animals, Insurance premium and transportation cost on "pro-rata basis" from the amount of subsidy released and kept in financial institution as back ended subsidy or under

Land Revenue Code. Also the beneficiary due to unforeseen circumstances is unable to rear the milch animals the same can be disposed off after taking the permission from the Department and re-paying the subsidy on "pro rata basis". In case of unfortunate death of the beneficiary the Government may waive off the subsidy, on returning the milch animals back to the Government in case no family members willing to rear the milch animals.

17) a) In case of death of animal, outstanding loan amount (in case of regular installments) pertaining to that animal shall be paid directly to the financing institution to the beneficiary's loan account from the death claim amount reimbursed by the Insurance Company and balance claim amount shall go to Government.

b) In the event of unfortunate death of the animal within one month from date of purchase, beneficiary has to report in writing to Area Officer within 24 hours of death. The Post Mortem of the animal is mandatory and photographs of Post Mortem conducted along with the Officer is required and the death of the animal should not be due to negligence on the part of the beneficiary, the cost of the animal shall be directly credited to the account of the beneficiary.

18) In the event of the animal undergoing permanent total disability (PTD) after duly certified by team of experts appointed by the Directorate of A.H. & V.S. for that purpose the farmer has option to dispose off the animal under the intimation to Directorate of A.H. & V.S., Panaji-Goa.

19) The animals purchased under the scheme will be covered under Comprehensive Insurance Policy for a period of 42 months and the premium towards insurance will be Rs. 16,625/- (maximum).

20) The Government may relax any of the clauses/conditions if deemed necessary.

21) The financial institution should take permission from the Department of A.H. & V.S. before closing the Kamdhenu Scheme loan account of the beneficiary.

22) Once a subsidy is released by Department loan EMI may be rescheduled by the financial institution on the balance principal amount.

23) a) The roofing material for the cattle shed should be of fire resistant materials as precautionary measure to prevent due to unavoidable circumstances catching of fire due to short circuit etc.

b) The shed should have pucca flooring, pucca manger and dung channel for housing the Cattle/Buffalo.

c) The cattle shed should not be constructed in low lying area, near to river banks or large sources of water which are prone to water logging and flooding due to heavy rainfall. Similarly applications with cattle shed being constructed in areas prone to water scarcity will not be considered.

d) Photograph of the cattle shed along with the applicant duly certified by Area Officer.

24) Any excess amount received by the beneficiary to be recovered under the scheme, will be done from milk incentive scheme/or any other schemes of the Department/under Land Revenue Code.

25) The Kamdhenu Scheme (Sudharit) Amended application or on line application will be scrutinized by the Committee constituted by the Director.

26) Those having more than 25 cattle require the consent of the Goa State Pollution Control Board to avail the scheme and as such the owner of cattle shed should apply for consent from the Goa State Pollution Control Board and produce the same to the Department of AH & VS. As per the guidelines for Environmental management of dairy farms and as per order passed by Hon'ble NGT on 20-05-2020 in the matter of O. A. No. 46/2018.

27) Those farmers who have availed benefits of the Kamdhenu Scheme (Sudharit) Amended or will avail the benefit of Mukhyamantri Sudharit Kamdhenu Scheme will not be eligible for availing benefits of Community Dairy Farming Scheme (Amended

2021) or any other Community Dairy Farming Scheme when amended and vice versa.

28) *Sale of Heifers/Cow.*— Farmers within Goa rearing calf to cow and are desirous of selling their Heifers/Cow may do so under Mukhyamantri Kamdhenu Sudharit Scheme, subject to the following conditions.

a. The farmer has minimum of 5 milch animals in his/her shed and registered with the Department.

b. The animal to be considered for sale has been registered with the Department through INAPH ear tagging at least 12 months prior with prescribed application.

c. The animals should be healthy, young, regularly vaccinated not exceeding 5 years of age and of 1st, 2nd and maximum 3rd lactation. In case of heifers, they should be confirmed pregnant.

d. The farmers whose calves are covered under the Pashupalan scheme are also eligible for sale after attaining the age of 27 months. In such instances, the subsidy received by the beneficiary under Pashupalan scheme has to repay the complete subsidy to the Government before selling the Heifers/Cow. The Department will further terminate the agreement bond of the scheme with the farmer of the registered calf if to be sold.

e. The price of the animal in question will be ascertained by a committee of officials from Department of AHVS and valuation certificate will be issued for the same. The Department has the right to accept or reject any or all such animals for the sale under Mukhyamantri Kamdhenu Sudharit Scheme without assigning any reason and it will be binding on the owner of the animal.

f. After purchase of milch animals of the 1st phase and if the mortality is more than 40% than further benefit of the scheme will not be allowed including the purchase of milch animals of the 2nd phase even if sanctioned.

29. The forms for registration of the animal to be sold under the Mukhyamantri Sudharit Kamdhenu Scheme will be available in all the Veterinary Hospitals/Dispensaries.

30. The processing fees for the Mukyamantri Sudharit Kamdhenu Scheme will be Rs. 200/- for General Category/OBC and Rs. 25/- for SC/ST/Dhangar Category.

Interpretation: If any question arises regarding interpretation of any clause, word, expression of the scheme, the decision shall lie with Government, which shall be final and binding on all concerned.

Note: This scheme is valid for three years from the date of Notification and can be extended further after evaluation.

Procedure for Application.— 1. The farmers interested in availing this facility will have to apply in a prescribed application form through area Assistant Director/Veterinary Officer.

2. A non-refundable processing fee of Rs. 200/- (Rupees Two hundred only) and for SC/ST/Dhangar Rs. 25/- (Rupees Twenty five only) shall be collected at the time of accepting the application at the respective Government Dispensary or Hospital.

3. On processing the cases (within 15 days) the Assistant Director/Veterinary Officer of the respective Hospital/Dispensary shall submit the application of all farmers eligible under the scheme to the Director of Animal Husbandry and Veterinary Services, for sanction by the Department.

4. Applications should be received in triplicate (Original plus 2 photocopies) along with all the documents as mentioned in guideline of the scheme.

The following Documents are required to release the subsidy:

1. The prescribed purchase statement should be certified and stamped by the Area Veterinary Officer/Assistant Director and Official of the financing institution and should be signed by the beneficiary.

2. Purchase and transport receipt should be attested with a stamp by the Area Veterinary Officer/Assistant Director and

Official of the financing institution and beneficiary, which should be enclosed along with the purchase statement mentioned at 1 above.

3. Proof of Insurance should also be enclosed together with the purchase statement.

4. Agreement bond sworn before Notary/Magistrate on stamp paper as per rule in force in Departmental prescribed format.

5. Subsidy will then be released as per the pattern of the scheme.

Infrastructure Component of Mukyamantri Sudharit Kamdhenu Scheme

It is felt that the farmer should be encouraged to construct cattle shed in scientific way and in order to do so Financial Assistance is required. It is proposed to subsidize 80% of construction cost for a cattle shed with an area of 5.4 sq. mtr. per animal and the construction cost @ Rs. 6,000/- per sq. mtr. Unit could be of 10 milch animals limited to maximum of 10 milch animals.

Unit of 10 milch animals.

Shed area per milch animal 5.4 sq. mtr., 54 sq. mtr.

Cattle shed cost @ Rs. 6,000/- per sq. mtr., Rs. 3,24,000/-.

Subsidy @ 80% Rs. 2,59,200/-.

Infrastructure component is linked to Mukyamantri Sudharit Kamdhenu Scheme. Release of subsidy shall be linked to number of milch animals purchased, minimum 50% of the unit strength @ Rs. 25,920/- per animal, shall be released as the benefit under Infrastructure Component of Mukyamantri Sudharit Kamdhenu Scheme. Infrastructure subsidy shall be released after purchase of animals. Bank loan is compulsory.

OR

The loose housing system in dairy is permitted with 54 sq. mtrs. for 10 animals carpet area. The maximum limit on purchase

of minimum 50% of the unit strength for the purpose of subsidy is Rs. 25,920/- per animal for cattle shed and for open area (Paddock) between 80 to 200 sq. ft. per animal, which will not be entitled for subsidy.

Farmer shall submit following documents at the time of application:

- 1) Copy of land ownership document.
- 2) Form I & XIV document.
- 3) The cattle shed to be constructed on own land having clear title in the name of the applicant on Form I & XIV or Sale Deed documents, Agreement received through Gift Deed will not be considered. Forest Land, Comunidade Land will not be eligible for approval.
- 4) Survey site plan.
- 5) Approved cattle shed plan from Government Authorized Engineer/Architect.
- 6) Copy of Bank Passbook/Mandate Form from financial institution.
- 7) License from the Panchayat/Municipality for the construction of cattle shed. TCP clearance is mandatory for construction of cattle shed.
- 8) Willingness from Bank/financing institution ready to finance.
- 9) Residence Certificate from the Mamlatdar/Sarpanch for 15 years.

Documents required for release of Subsidy after completion of unit:

1. Valuation Certificate from an Approved Valuer.
2. Occupancy Certificate from Panchayat/Municipality.
3. Receipts/Vouchers towards completion of cattle shed.
4. Completion Certificate from Area Assistant Director/Veterinary Officer.
5. Notarized Agreement Bond in prescribed format.

The Government of Goa is pleased to introduce the following Scheme:—

Wired Internet Scheme for ICT Laboratory in Schools in the State of Goa

1. *Short title and commencement.*— i) This scheme shall be called “The Wired Internet Scheme for ICT Laboratory in Schools in the State of Goa”.

ii) It shall be applicable to all the Government Schools and Government-Aided Schools under the Directorate of Education of the Government of Goa.

iii) The scheme shall come into force from the date of its publication in the Official Gazette.

2. *Preamble.*— The State of Goa is developing speedily as an educational hub and internet services have become an integral and indispensable part of the education system for communication, learning along with the spread of knowledge, so as to make the student equipped for the digital world. Digital India is a flagship programme of the Government of India with a vision to transform India into a digitally empowered society and knowledge economy. The Government of Goa has taken various initiatives to promote various of the envisioned Digital India programmes, specially promoting Education through Information and Communication Technology. To facilitate these initiatives internet services is a much needed infrastructure that is needed to provide learning tools, usage of MOOC's platform for learning, towards developing needed digital, computational, and other related skills; all this for the benefit of the students.

The Government of Goa has through various initiatives provided top of the class ICT infrastructure in the school laboratories.

To provide internet services to the schools ICT laboratories so as to promulgate enhanced learning, the Government of Goa is pleased to constitute "The Wired Internet Scheme for ICT Laboratory in Schools in the State of Goa" envisaging grant of monthly rental reimbursement to avail internet services from a local internet services provider, for Government or Government-Aided Schools in the State of Goa.

3. *Objectives.*— The main objective of the scheme is to provide monthly rental reimbursement to avail internet services to the ICT Laboratory in Government and Government-Aided Schools in the State of Goa. This is provided so that the teachers/students teaching/learning is enhanced by using various digital educational tools, MOOC's platform and other services/contents of various national/international institutes, various Digital India initiatives towards education; which would be made available free of cost in the schools.

4. *Eligibility.*— i) All Government and Government-Aided Schools in the State of Goa having dedicated ICT Laboratory with at least 03 working Computer Systems would be eligible to apply under this scheme.

ii) The school should have a minimum student enrolment as prescribed by the Directorate of Education.

iii) The Internet Service Provider/Internet Vendor would need to provide 50 Mbps upload and download speeds at 1:10 contention ratio and unlimited data through Optical Fibre Connection.

iv) The Internet Service Provider/Internet Vendor would need to provide Service Level Agreement (SLA) for rectification time after complaint is logged in the Internet Service Provider/Internet Vendor provided portal as such:

a. Minor Fault (Last mile issue, device issue, etc.): 04 to 08 hours.

b. Major Fault (Major Links Down, Underground cable cut, etc.): 24-48 hours.

c. The link uptime should be not less than 97.5%.

v) The number of schools selected would depend on the availability of the financial provisions made. Priority would be given to remote/rural schools.

vi) The school ICT Laboratory should not have availed of any internet services through any other schemes of the State or Central Government agencies or bodies.

5. *Quantum of Award.*— "The Wired Internet Scheme for ICT Laboratory in Schools in the State of Goa" would provide a monthly rental reimbursement of upto Rs. 2000/- (Rupees Two thousand only) to the Head of the Government and Government-Aided Schools in the State of Goa to avail the internet service to their respective schools ICT Laboratory.

6. *Selection Procedure.*— i) The Directorate of Education shall make communication of the scheme to the management of eligible Government and Government-Aided Schools in the State of Goa.

ii) The Head of the eligible Government and Government-Aided Schools from the State of Goa, would need to select the Internet Service Provider/Internet Vendor that would provide the required internet service as specified in the section (4) Eligibility, sub-section (iii).

iii) For the purpose of scrutiny/inspection of the internet service availed by the Government and Government-Aided Schools from the State of Goa, the Directorate of Education with the approval of the Government shall constitute a committee.

iv) The Head of the eligible Government and Government-Aided Schools from the State of Goa, would have the flexibility to change/ /dis-continue the services of the Internet Service Provider/Internet Vendor, due to non-adherence to the SLA clause as specified in the section (4) Eligibility, sub-section (iv). Same would have to be communicated to the Directorate of Education.

7. *The sanction of financial support shall be subject to the following conditions.*— i) The

financial support will be released to the Head of Government and Government-Aided Schools through the Directorate of Education.

ii) The school shall maintain proper records/register.

iii) Any portion of financial support which is not utilised or is not ultimately required for the purpose for which it is sanctioned, shall be remitted to the Government Treasury.

iv) The financial support shall be utilised for the purpose for which it is sanctioned and shall not be utilised or diverted for any other purposes.

v) The Deputy Director Education of each Educational Zone shall draw and disburse the financial support on receipt of sanction order, based on the selection procedure mentioned in section 6.

vi) The accounts/registers and other records of this scheme shall be open to check by the Director of Education or his authorised representatives.

8. *The expenditure shall be debited to the Budget Head.*— “Demand No 34—School Education; 2202—General Education; 02—Secondary Education; 800—Other Expenditure; 32—Wired Internet Scheme for Remote Schools; 50—Other Charges”.

9. *Framing of Guidelines.*— For better implementation of this scheme the Director of Education may frame guidelines from time to time, if required.

10. *Relaxation.*— The Government shall be empowered to relax any or all clauses or conditions of the scheme in genuine cases for sanction of the award.

11. *Interpretation.*— If any question arises regarding interpretation of any clause, word, expression of the scheme, the decision about the interpretation shall lie with the Director of Education, which shall be final and binding on all concerned.

12. *Grievances.*— Grievances if any, arising out of the implementation of the scheme, the Director of Education, shall hear and decide

such matters and the decision of the Director of Education in this regard shall be final and binding on all concerned.

The scheme is administratively approved by the Government vide U. O. No. 1543/F dated 17-02-2023. The Finance Expenditure Department has approved the scheme vide U. O. No. 2416/F dated 28-10-2022.

**Directions under section 5 of the
Environment (Protection) Act, 1986 for
implementation of ban of Single Use
Plastic (SUP)**

Whereas, the Ministry of Environment, Forest & Climate Change (MoEF&CC) notified the PWM Rules, 2016, in exercise of the powers conferred under section 3, 6 & 25 of the Environmental (Protection) Act, 1986 vide Notification No. G.S.R. 320 (E) dated March, 2016;

Whereas, Ministry of Environment, Forest & Climate Change (MoEF & CC) Amendment the PWM Rules, 2016, related to Single Use Plastic vide Notification No. G.S.R. 571 (E) dated August 12, 2021;

Whereas, Rule 4(2)(b) of PWM Rules, 2016 (as amended), “The manufacture, import, stocking, distribution, sale and use of following single use plastic (SUP), including polystyrene and expanded polystyrene, commodities shall be prohibited with effect from the 1st July, 2022:

(a) ear buds with plastic sticks, plastic sticks for balloons, plastic flags, candy

sticks, ice-cream sticks, polystyrene [Thermocol] for decoration;

(b) Plates, cups, glasses, cutlery such as forks, spoons, knives, straw, trays, wrapping or packing films around sweet boxes, invitation cards and cigarette packets, plastic or PVC banners less than 100 micron, stirrers.

Whereas, as per Rules 4(1)(c) of PWM Rules, 2016 (as amended), "Carry bag made of virgin or recycled plastic, shall not be less seventy five microns in thickness with effect from the 30th September, 2021 and one hundred and twenty (120) microns in thickness with effect from 31st December, 2022";

Whereas, as per Rule 4(d) of the PWM Rules, "plastic sheet or like, which is not an integral part of multilayered packaging and cover made of plastic sheet used for packaging, wrapping the commodity shall not be less than fifty microns in thickness except where the thickness of such plastic sheets impair the functionality of the product";

Whereas, as per Rule 12(1) of PWM Rules, "the State Pollution Control Board and Pollution Control Committee in respect of a Union territory shall be the authority for enforcement of the provisions of these rules relating to registration, manufacture of plastic products and multilayered packaging, processing and disposal of plastic wastes";

Whereas, as per Rule 12(2) of PWM Rules, "the concerned Secretary-in-charge of Urban Development of the State or a Union Territory shall be the authority for enforcement of the provisions of these rules relating to waste management by waste generator, use of plastic carry bags, plastic sheets or like, covers made of plastic sheets and multilayered packaging";

Whereas, CPCB issued Directions dated 30-6-2022 to all State UDDS to implement necessary measures for enforcement of SUP ban as per Notification dated August 12, 2021 issued by MoEF&CC;

Whereas it was further observed that the plastic film on such items was often coloured to create an illusion that agro-based material was used in manufacturing of such items which was not only in violation of the SUP ban but also endangered the health of the users, as the colour tends to run off upon usage; and

Whereas CPCB issued following Directions dated March 01, 2023 to all State UDDS:

1. To follow the steps defined in Standard Operating Procedure (SOP) for conducting inspection drive for enforcement of SUP ban.

2. To conduct combined inspection drive with State Boards for 4 days in a month for next six months (March to August, 2023) focusing on commercial establishments, hotels, restaurants, institutions, street vendors, local shops, wholesale markets, interstate borders, bus depots, railway stations, airports etc.

3. To deploy concerned officials and provide all necessary assistance for execution of the planned activities for enforcement of SUP ban.

4. Register all the concerned field officer on SUP field inspection app and conduct inspections before 25th of every month for timely submission of auto generated inspection report on SUP compliance monitoring portal through field inspection app.

5. To take action against the entities for violation of SUP ban at the time of inspection and uploading of report on SUP field inspection app.

6. To take action against the complaints received on SUP Public grievance app within seven days of registration of complaint on app.

7. To identify SUP Producers engaged in production of banned SUP items in informal sector/suppliers of plastic raw material to such producers through contact tracing/

/public notice/public grievance reporting etc. & initiating action against them in association with State Boards.

Whereas, CPCB further conducted inspections in April & May 2023 in Bhagalpur Area and identified several shops selling such plastic coated items as well as other banned SUP items. It was observed that the supply of banned SUP items was being maintained through clandestine means. Through contact tracing, industries engaged in manufacture of such industries were identified, which were located not only in Bihar but in other States also. A total of 23 shops selling SUP items were identified in Bihar. Further 77 Suppliers/manufacturers (West Bengal-60, Bihar-17 & Delhi-2) of SUP items were identified during the inspection;

Whereas, continual sale & usage of Single Use Plastic items including the plastic coated items is in gross violation of PWM Rules, 2016 (as amended);

The Government of Goa is in receipt of the Directions issued by the CPCB under Section 5 of Environment Protection Act, 1986 for implementation of ban of Single Use Plastic (SUP) as listed above.

Now, therefore, in view of above and in exercise of powers vested under Section 5 of Environment (Protection) Act, 1986 to the Director/ex-officio, Jt. Secretary (Environment & Climate Change) following directions are issued for compliance:

1. To conduct exhaustive inspection drives at regular intervals in the area under your jurisdiction along with State UDDS to identify manufacturers and suppliers of banned SUP items including the plastic coated SUP items through contact tracing.
2. To identify the suppliers of banned SUP items in your area through contact tracing.
3. To take necessary action against the violators including imposing penalty, seizure of SUP items, levying environmental compensation, suspension of

commercial license/sealing of the manufacturing.

4. To conduct regular checking at entry and exit points of the State boundaries to ensure that banned thin plastic layered plates and other SUPS are not being supplied to the respective States.
