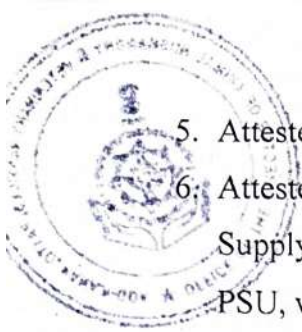
1. The last date of online submission is on **6th July 2026** upto **3.00 P.M.**
2. The Tender (Technical Bid) will be opened online on **7th July 2026** at **10:30 A.M.** in the Office of Director of Animal Husbandry & Veterinary Services, Panaji-Goa followed by scrutiny of the samples submitted for approval. The Financial bid of the tenderers fulfilling the Terms and Conditions of the Technical Bid will be opened subsequently.

The dates mentioned above shall be treated as the next working day if any of the dates fall on holiday.

Request of Tender Forms:-

Request for the Tender documents may be made through the website <https://eprocure.goa.gov.in> on the following conditions:-

1. Documentary evidence to substantiate that the Tenderer is the original Manufacturer or under Loan and License agreement/third party manufacturer.
2. Copy of Tender Documents duly signed by the Manufacturer.
3. Attested copy of PAN Card.
4. Attested copy of GST Certificate.



5. Attested copy of GMP Certificate of the Manufacturer.
6. Attested copy of Non Conviction Certificate from State Drug Controller or Supply Order from Government of India or any other State Government or PSU, which should not be more than one year old.
7. Name & Address of Manufacturing Firm of each item quoted.
8. Certificate of Turnover duly certified by the Chartered Accountant.
9. Copy of the Income Tax Returns for Assessment Year 2024-25.
10. EMD 2.5% on the amount of quoted items.
11. **Mode of Payment towards cost of the Tender Document, Earnest Money Deposit (EMD) and tender processing fee: to be paid online through e-Payment mode via: National Electronic Fund Transfer (NEFT) / Real-Time Gross Settlement (RTGS) /Net Banking with pre-printed Challans available on e-tendering website generated by challans for NEFT/RTGS.**
12. The Eligible Manufacturer who has not registered with Goa Infotech Corporation Ltd., Altinho, Panaji, Goa and intending to participate in online Tendering may register now on <https://eprocure.goa.gov.in> and apply before the last date of application.
13. The bidder should upload a Self Declaration Certificate regarding exemption of EMD for number of items quoted.
14. Individual sample of medicines in sealed pack to be submitted to the Head Office on or before **7th July 2026 at 10.00 A.M.**

The Director of Animal Husbandry & Veterinary Services, Panaji reserves the right to accept or reject any tender or all the tenders without assigning any reason thereof and his decision in this regard shall be final. For any legal dispute the jurisdiction will be at Panaji, Goa only.

General Terms and Conditions of Tenders for the Purchase of Veterinary Medicines (Dewormer) during 2026-27.

1. The Manufacturers of Veterinary drugs/ dewormers should quote the rates for the products either manufactured by them only or under Loan and License agreement/third party manufacturers.
2. The rates should be quoted only for the specified pack/unit mentioned in the Annexure which should include all charges such as packing forwarding insurance etc. Damages and losses are at suppliers' risk.
3. The Department of Animal Husbandry does not bind itself to accept the lowest or any other rate and reserve the right to select from any tender, only such articles as it may consider expedient to accept. The Committee shall identify only the best of the drugs/Medicines/dewormers which in its opinion would be required for the use of various field establishments in the State and various species of animals, wherein Quality and efficacy shall supersede cost and the Committee in its opinion finds it expedient to purchase only such quality Medicine in the best interest of the animals and farmers at large.
4. The company should have a minimum turnover of **Rs.50.00 Lakhs** in case of Veterinary Allopathic Medicines in a Financial Year which should be duly supported by a Certificate issued by a Chartered Accountant.
5. Each article mentioned in the schedule will be considered as a separate and distinct tender itself and rates for each item should be quoted separately.
6. Tenderer should submit attested copy of following documents:-
 - (I) PAN Card.
 - (II) GST Certificate.
 - (III) G.M.P. certificate.
 - (IV) Good Market Standing Certificate.
 - (V) Non Conviction Certificate.
 - (VI) Income Tax Returns of the Assessment Year 2024-25 and Turnover Certificate.
7. The Name and Address of the Manufacturing Firm of each item should be mentioned specifically in the tender.



8. (a) The manufacturers of medicines/ dewormers should have currently valid Good Manufacturing Practice (GMP) Certificate as per the requirement of the Drugs and Cosmetic Act and rules of Government of India from Competent Authority. Copy of the Certificate issued by the Competent Authority of the concerned country, in case of imported medicines /vaccines is to be furnished by the tenderer. The state Govt. reserves the right to have the premises of the manufacturers inspected for ensuring that "GMP"(GOOD MANUFACTURING PRACTICES) are as per revised schedule 'M'.
- (b) The manufacturers of medicines should have been approved and permitted by the Competent Authority.
- (c) The tenderer has to submit & upload Non-conviction certificate(s) issued by the concerned Drugs Licensing Authority. The certificate should be latest one i.e. issued during past twelve month prior to the date of opening of tender along with certificate that the quoted product has not been declared as not of standard quality/spurious/adulterated for past three years.
9. **All supply of Veterinary Medicine/ dewormers should be accompanied with the batch wise authentic test reports from Govt. recognized labs. The Department has right to send the sample/s from consignment received for testing to the Govt. recognized laboratory.** If the product is found to be Not of Standard Quality, the total cost of the test will be recovered from the supplier and the supplier will have to replace the entire consignment irrespective of the fact that the stores supplied may have been consumed. The tenderer will be liable for relevant action under the existing laws and the entire stock in such batch has to be taken back by the Tenderer within a period of 30 days of the receipt of the letter from Tender Inviting Authority. Such stock shall be taken back at the expense of the Tenderer. The Tender Inviting Authority has the right to destroy such "NOT OF STANDARD QUALITY" stock if the Tenderer does not take back the goods within the stipulated time. Tender Inviting Authority will arrange to destroy the "NOT OF STANDARD QUALITY ITEMS" within 90 days after the expiry of 30 days mentioned above without further notice, and shall also collect demurrage charges calculated at the rate of 2% per week on the value of the drugs rejected till such destruction. The cost of destroyed stock will be deducted from any pending bill of the Firm or from EMD/ SD and the amount will be recovered from the concerned Firm / Tenderer as Revenue Arrears

10. The Medicines having I.P/B.P/USP/B vet C/ BPC/ NF specification only should only be quoted.
11. a. Supply of drugs should be made to the Office of the Assistant Director, I/c. Key Village Scheme, Central Stores, Curti-Ponda, Goa or any other place as it may be specified on the supply order on DOOR DELIVERY basis.
b. The prices quoted should be INCLUSIVE OF ALL APPLICABLE TAXES. The offer should be valid for the period of one year from the date of acceptance of tender and no rise in prices will be considered during the above period.
c. Order to the successful Tenderer shall be placed directly to the Company only. The Company shall supply the entire quantity of Medicines directly to the Department.
d. All labels on containers and other wrappers shall be stamped with words "Goa Government Supply" (G.G.S.) NOT FOR SALE.
12. The successful Tenderer has to sign a contract/agreement on stamp paper of Rs.1000/-(Rupees One Thousand Only) with such Terms & Conditions and the costs to be borne by the Tenderer, and the same is to be signed in presence of the Director of Animal Husbandry & Veterinary Services, Panaji-Goa and duly Notarized.
13. The successful Tenderer has to produce Security Deposit corresponding to 10% (Ten percent) of the total value of the cost of medicines/ dewormers for which supply order is issued, in the form of Demand Draft drawn in favour of Director, Animal Husbandry & Veterinary Services of any Nationalized Bank payable at PANAJI. EMD paid is adjustable with the Security Deposit.
14. All containers should comply with statutory regulations to ensure total protection to the quality of the products packed during shelf life.
15. Failure to supply entire quantity of indents within specified period from the date of placing orders will entail the enforcement of any or all of the following :-
Cancellation of order in part or whole.
Black listing of firm for 3 (three) years.
Forfeiture of EMD/Security Deposit.
16. The delivery of medicines/ dewormers should be within 30 days of a calendar month from the date of receipt of firm order on a quarterly basis or as and when felt necessary by the Directorate, failing which the EMD/Security Deposit will be forfeited and order will be cancelled.



17. If the supply is not made within the stipulated time for any reason whatsoever, the Director of Animal Husbandry or the prescribed Authority will make the requisite purchases from the open market and its difference of cost shall be recovered from the Tenderer or adjusted against EMD/S.D.
18. The Medicines supplied should have a minimum of one year shelf life from the date of supply.
19. The individual sample of the medicine quoted by the Tenderer should be submitted to the Department alongwith Hard copies of the Technical Bid documents for necessary verification and to ensure that they conform exactly with the ingredients as mentioned in the Tender Specification.
20. Supply order shall be placed with the eligible Tenderer after verifying the samples and after certifying that they conform exactly with the specifications as prescribed in the Tender.
21. Parties should quote only if they agree to the terms and conditions as stipulated in the Tender.
22. Medicines/ dewormers which cannot be consumed before its expiry date will be returned to the supplier atleast 3 months before its expiry date and the firm shall be responsible for the replacement of the stocks with the longer shelf life or issue a credit note for the value of stock taken back.
23. In the matter of dispute in respect of proper performance of contractor /supplies not in conformity with the terms and the conditions of the agreement, the decision of the Director of Animal Husbandry, Panaji will be final and binding on the suppliers.
24. Disputes if any will be dealt within the jurisdiction of Panaji Courts, Goa State.
25. Payments will be made through Electronic Clearance System (ECS) only after the receipt of goods in good condition and correct quantity. No instruments shall be accepted through the Banks.
26. The Director of Animal Husbandry reserves the right to alter the quantity, packing combination or ingredients mentioned in the annexure without prior notice.
27. The Director of Animal Husbandry reserves the right to accept/reject any or all Tenders without assigning any reason thereof and his/ her decision in this regard shall be final and binding.
